Currently three courses namely Civil Engg., Civil Engg.(EPC) and Mechanical Engg.(Production) are running in the institute. Institute is affiliated to Board of Technical Education, Uttar Pradesh (UPBTE) and all the courses are approved by AICTE, New Delhi.


AND

D4E Network India Private Limited, (CIN:U74999TN2017PTC118224) a company incorporated under Companies Act,1956 having its registered office at Old No. 37, New No. 13, Jayalakshmiapuram First Street, Nungambakkam Chennai TN 600034 (hereinafter referred to as D4E Club), which expression shall, unless repugnant to the context or meaning thereof, shall include its successors and permitted assigns of the SECOND PART.

Government Polytechnic Bargarh (Chitrakoot) and D4E Club are hereinafter referred to singly as "Party" and jointly as "Parties".

WHEREAS:

- A. Government Polytechnic Bargarh (Chitrakoot) is an Educational Institution Managed by Govt. of Uttar Pradesh and was set up to fulfil the growing need in India for imparting education , skills for employment to youth
- B. - C. The Parties mutually agree to enter into this MOU to record the terms and understanding between the Parties and the manner in which the Parties wish to combine their efforts and collaborate with each other on the Engagement initiative , as below .

- (ix) Governing law and Jurisdiction: This MOU and any matter relating to this MOU shall be governed by and construed in accordance with the laws of India, and shall be subject to exclusive jurisdiction of the courts at Delhi.
- (x) Counterparts: This MOU may be executed in counterparts, each of which shall be deemed to be the original and all counterparts shall collectively constitute a single instrument.
